The U.S. Environmental Protection Agency (EPA) Region 7 is seeking public input on four Proposed Plans to address lead and other heavy metal contamination in private, domestic drinking water wells at residential properties located within the Washington County Lead District (WCLD) National Priorities List (NPL) Superfund Sites, which include Furnace Creek, Old Mines, Potosi and Richwoods.

EPA's Proposed Plans summarize different options (also known as alternatives) to address lead contamination in private wells under an interim (intermediate) action. Lead mining waste was dispersed throughout the area from historic lead and barite mining activities in the area; lead is the main contaminant of concern at this site. Lead is a toxic metal that is harmful if inhaled or swallowed. It affects multiple body systems and is particularly harmful to young children. Since 2006, over 4,500 private drinking water wells have been tested in Washington County with approximately one out of seven wells being contaminated with lead and/or other heavy metals

(such as cadmium, arsenic or barium). To prevent residents from drinking contaminated well water, EPA has supplied water treatment or bottled water to residents with impacted wells.

PROPOSED PLAN OVERVIEW: EPA is asking for public input on four options, including the recommended option, Point-of-Use Treatment Systems with Institutional Controls and Health Education. Under this recommended cleanup option (also known as the preferred alternative), residential properties with lead or other heavy metal contamination in their private drinking water wells will be eligible for EPA to install Point-of-Use (POU) water filtration units or treatment systems (also known as drinking water filters). Drinking water filters will need to be changed to properly maintain the system to meet health-based standards for drinking water.

HOW TO COMMENT: Public comments on the Proposed Plans will be accepted from Tuesday, July 19, 2022, through Thursday, August 18, 2022. Upon timely request, the comment period can be extended by an additional 15 days. On July 19, the Proposed Plans and Administrative Record files (AR files) for these actions will be published online for public review at the weblinks included below. EPA will host two Public Meetings with an EPA presentation to share information about the Proposed Plans, followed by an opportunity to provide verbal and/or written comments about the plans.
